

More Scrutiny Welcome!

Last month saw a significant development in our fight against Veolia's proposed waste incinerator in Tarago. The NSW Legislative Council has announced a new Parliamentary Inquiry into in c in e r a t o r

proposals across the state - including Tarago! This provides an excellent opportunity to get on the record exactly why these projects are wrong for NSW and catastrophic for towns like ours.

The inquiry's terms of reference are broad (Ref 1), covering everything from the environmental and health impacts of waste incineration to the impact on agriculture, rainwater harvesting and soil contamination. It will also cover the impacts of Veolia's existing landfill operations here in Tarago over the last twenty years, meaning a light can be shone on Veolia's woeful record of consistent license breaches and negative impact on the local community.

This consideration of Veolia's past behaviour is important. Over the years, we have endured odour events so bad they've made people physically ill. We've seen water contamination risks flagged repeatedly, including the NSW EPA's own recent notification about excessive levels of contaminants and PFAS in creeks surrounding Woodlawn and linking the chemicals found to landfills (Ref 2). We've watched as Veolia has racked up numerous fines, breach notices and warnings for non-compliance with license conditions. And we've witnessed the cumulative effect of having a mega-landfill in the middle of a rural community that relies on tank water, clean air, and healthy soils for our livelihoods.

That impact is the smell on the morning and evening air; the trucks rumbling past our homes; the creeping worry about what's leaching into our waterways. It's the knowledge that despite decades of operation, we still face unacceptable environmental risks and impacts from the landfill. And now Veolia and the NSW Government want to add a toxic incinerator into the mix.
